Dear ABCA,

At the April 15, 2025 public meeting of Advisory Neighborhood Commission (ANC) 5E, the new license application of Alotmo, LLC, for a Retailer's Class "C" Tavern, Trade Name is noted as 'TBD' at 406 Florida Avenue, NW, was on the agenda, and the following facts were determined:

1. The applicant's tavern, Alotmo, LLC is located in Single Member District (SMD) 5E02.
2. The granting of the requested new license for Alotmo, LLC will have a harmful and negative effect on the peace, order, quiet, trash, and parking in the neighborhood and there is great concern among neighbors that if the new license is approved, the quality of life of the residents will be severely impacted by increased noise particularly in the evening and late night hours and concerns about inadequate crowd management on a public sidewalk in the 400 block of Florida Avenue NW and the 1700 block of 4th Street, NW.
3. The approval of the new license to Alotmo, LLC will only exacerbate the litter issues currently being experienced by residents and it would cause an increase in vehicular traffic.

Based on these findings, ANC 5E, on April 15, 2025, with 0 of 6 elected Commissioners present, 4 representing a quorum, voted 6 in favor, 0 opposed, with 0 abstentions, to protest the new Retailer's Class "C" Tavern License to Alotmo, LLC, at 406 Florida, NW. ANC 5E also authorized Commissioner Lewis to represent the Commission in all matters relating to this application.
