
On Tuesday, January 21, 2025, Advisory Neighborhood Commission 5E (ANC5E), at its duly noticed public monthly meeting, voted to support and endorse the 2025 Rock N Roll DC Half Marathon, which is scheduled to take place on Saturday, March 15, 2025. This is an annual event that has been well received in our community. It presents an opportunity for neighbors to meet and to share our pride in our neighborhood with runners from across our city and beyond.

The course runs, in part, through ANC5E service area, passing through the 100 and Unit blocks of Bryant Street, NW before turning right and running southbound along North Capitol Street to and across New York Avenue.


Proper notice of the January 21, 2025 public meeting was given to the community. Seven calendar days prior to the meeting, the agenda was posted on the ANC 5E website and all local listservs and blogs and commissioners posted the agenda in conspicuous locations throughout their respective Single Member Districts or distributed it by email to their constituents. At the meeting, Commissioners and residents who were present virtually, had a full and fair opportunity to raise questions and express concerns, but no opposition to the event was articulated.

ANC 5E is comprised of 6 Commissioners, the presence of 4 of whom constitutes a quorum. X Commissioners were present at the meeting and the Commission voted unanimously, 6-0-0, in favor of the motion to support. Accordingly, on behalf of ANC5E, we hereby request that you give this recommendation Great Weight and approve the applicant's request for permitting this event.
